See the difference cover makes Income Protection

If you have been putting off discussing financial protection, here is a case example that shows how important it can be. We often hear clients express they don't know how they would have coped without the payouts received. More than that though, it's the support they get from their financial protection adviser which makes a massive difference.

When Fabiano met his client to discuss cover Mr X was fit and healthy, although he expressed at times he felt muscle pain. Following a review of various cover options, Mr X, decided to take Fabiano's advice to apply for an Income Protection policy. He took this as part of other cover options. As a concierge and dad, he wanted to make sure that if for any reason he couldn't work, there would be some money available to support his family and pay the rent and other necessary bills. Following underwriting, the policy was issued, with an exclusion in place relating to muscle pain.

A few years after taking the policy, Mr X started feeling very unwell. He was having epilepsy episodes and symptoms were worsening, plus also experiencing some memory loss. Things got to the point where Mr X was unable to work. Fabiano had been in regular contact since he had taken the policy, so Mr X had no hesitation in contacting him for help on how to make a claim under the policy. Without Fabiano's support Mr X recalls, "I don't know what I would have done. He was there for me and the family, plus helped guide us through the process".

Due to the exclusion, there was various dialogue between the insurer, the client and Mr X's GP. Throughout this, Fabiano was there to support the family. When the letter came confirming the claim would be paid - £1,000 per month, in line with the terms of the policy, Mr X was relieved. As part of the income protection policy he had taken, ongoing payments would be paid to him for up to two years whilst he was unwell.

As well as financial support, Mr X has been able to benefit from well-being and rehabilitation services, that come as part of the policy. All of this has meant he can focus on getting better, without the added worry about paying for everyday living expenses. Things could continue, as normal, for his family, whilst he's off work.

Mr X's only regret is that he didn't go for the income protection policy option which would have given him a payout beyond two years. He has so far received around **£20,000** as part of the cover taken.

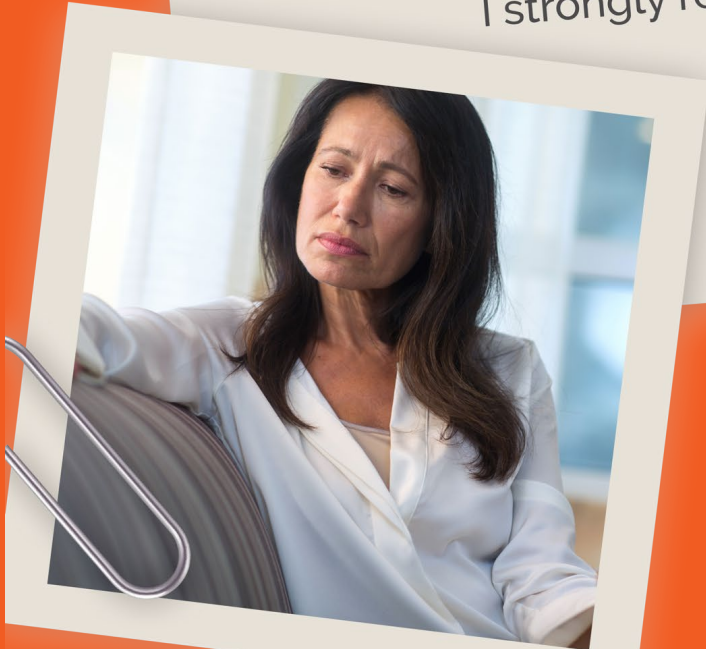
